The Council for the Arts Art Block 2019 Festival is scheduled for May 18, 2019! The Art Block Opening Reception will be held Friday evening, and the grand finale will be Saturday's Art Block event! This is an outside event on the Arts Council block, 826 New Bridge Street Jacksonville, located across from Jacksonville City Hall and Freedom Fountain. We are currently inviting vendors to reserve their spots for Saturday, May 18, from 10:00 a.m. to 4:00 p.m. We anticipate more vendor interest than last year which was most successful!

Vendors are welcome to attend the free Art Block Opening Reception on Friday, May 17, 2019 from 6:00-8:00 p.m. Light refreshments will be served.

Food vendor fee is \$100.00 for a food truck space. Vendors must provide their own equipment, power and water. No pets allowed. No alcohol is allowed or sold. Vendors are required to clean up their area and leave it free of litter. If selling food, the food permits will be the responsibility of the vendor.

Vendors must send in applications to the Health Department NO later than April 18, 2019. Booth assignments will be distributed at check-in. All vendors must be set up and ready for health inspection by 8 a.m. Vehicles must be moved from the street by 9:30 a.m. to the designated vendor parking area, and ready to sell by 10 a.m. Break down time is 4 p.m., as the block will be re-opened to public transportation after 5:00 p.m.
